- II. Discussion of 7 proposed foreclosure units by Evan Phillips from Alliance. If a bank is in the process of foreclosure that unit is not a candidate for foreclosure. Alliance has 7 initial candidates for foreclosure. The process can take from 9 months to one and one-half years.
